Crime Statistics

The Uniform Crime Report (UCR) contains official data on crime and criminal offense information that is reported by law enforcement agencies across the United States to provide data to the Federal Bureau of Investigation (FBI). Each month, law enforcement agencies report the number of known index crimes in their jurisdiction to the FBI. This mainly includes crimes reported to the police by the general public, but may also include crimes that police officers discover, and known through other sources. Law enforcement agencies also report the number of crime cases cleared. For reporting purposes, criminal offenses are divided into two major groups: Part I and Part II offenses.

In Part I Offenses, the UCR categorizes reported incidents in two categories: Violent and Property Crimes. Aggravated assault, forcible rape, murder, and robbery are classified as violent while arson, burglary, larceny-theft, and motor vehicle theft are classified as property crimes. Collectively known as *Index Crimes*, these crimes are considered quite serious in nature, tend to be reported more reliably than others, and are reported directly to the police.

In Part II Offenses, the following categories are tracked: simple assault, quality of life offenses, forgery and counterfeiting, disorderly conduct, driving under the influence, drug offenses, fraud, gambling, liquor offenses, offenses against the family, prostitution, sex offenses, stolen property, criminal mischief, weapons offenses, and all other offense classifications.

Many factors may contribute to fluctuating levels in Part I and II Offenses including weather, economic conditions, unemployment rates, alcohol and drug abuse, proactive community policing and enforcement initiatives, new technologies, community involvement, and patrol presence.

Currently, poor economic conditions and high unemployment rates continue to affect the Tri-State region. Unfortunately, these difficult economic times combined with the increase abuse of heroin, prescription pain medications, and crack cocaine have contributed to criminal acts such as burglary, larceny, fraud, and domestic violence.

PART I and PART II Crime Highlights

In 2011, the City of Port Jervis experienced an overall decrease in Part I Offenses from 2010 by 6.8%. Most notably, the following decreases were observed in these major categories:

- Larceny: 8% decrease
- Aggravated Assault: 43.75% decrease
- Forcible Rapes: 75% decrease
- No reportable increase in armed / forcibly robberies

Unfortunately, the following Part I Crimes have observed notable increases in 2011:

- Burglary: 8.7% increase
- Motor Vehicle Theft: 40% increase

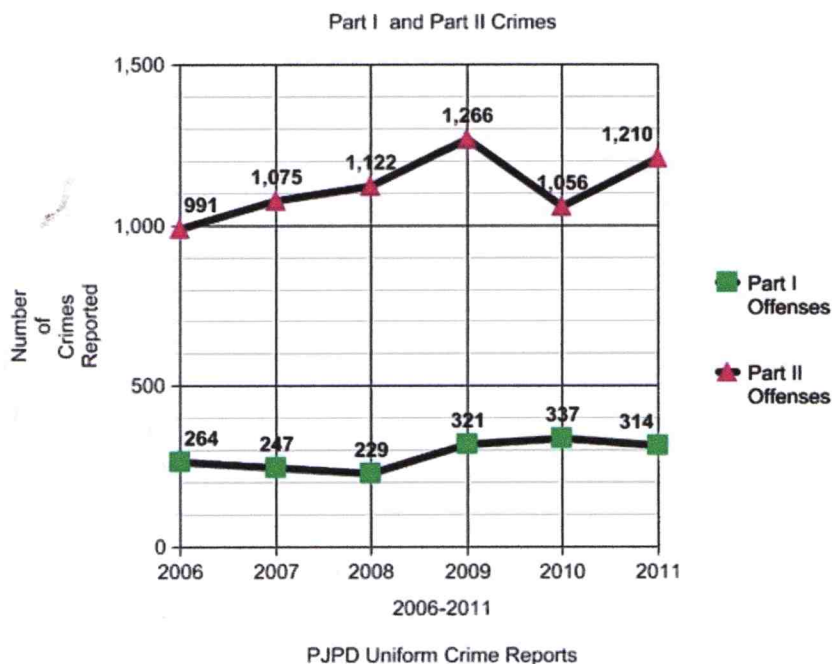
Our community experienced its first murder since 2004 with the tragic death of a twenty-two year old Port Jervis resident who was shot and killed on Prospect Street on February 2, 2011 by Todd Sinclair. Sinclair is currently being held at the Orange County Correctional Facility on Second Degree Murder charges and is awaiting a trial in Orange County Court.

Part II offenses as compared to 2010 increased by 14.5%. Most notably, increases were observed in the following areas:

- Controlled Substance offenses (sale and possession): 13.3 % increase
- Simple Assault: 11% increase
- Quality of life, liquor law violations, and city code violations: 23.8% increase
- Criminal Mischief: 14.6% increase

Figure 1 represents the total number of Part I and Part II reported offenses between the years of 2006 through 2011. Part II Offenses have increased by 22% since 2006 while Part I Offenses have increased by 18.9% respectively.

Figure 1: Part I and Part II Offenses 2006-2011



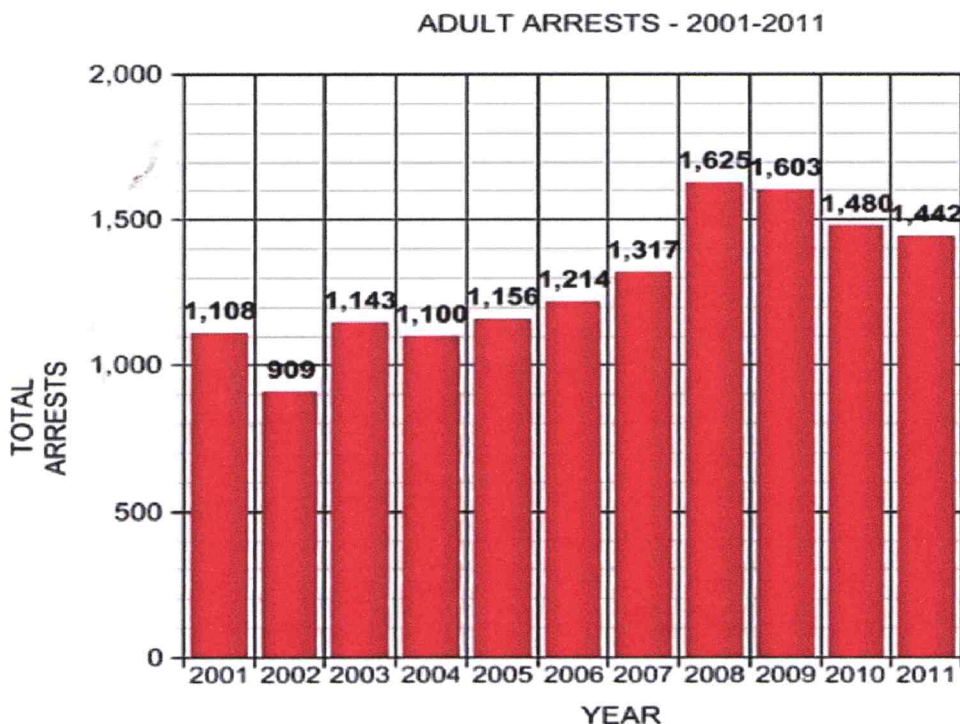
In 2010, a supervisory detective position was added to the Detective Bureau which has resulted in an increased level of investigative expertise, case supervision, and investigative capacity.

During 2011, the department observed the following activity with regards to narcotics related enforcement efforts:

- 13% Increase in controlled substance related cases and investigations
- 68 marijuana related arrests
- 94 controlled substance related arrests
- 66 charges levied against individuals for sale or intent to sell a controlled substance
- 217 drug related charges filed
- 60% increase in felony level drug charges
- 20 Search Warrants executed; 12 specifically for narcotics related offenses

In 2011, a total of 1,442 adult criminal arrests were affected by members of the Port Jervis Police Department. These arrests include petty offenses and crimes committed by persons age 16 and older. Representing a 2.5% decrease from 2010, arrests have increased 30% since 2001. Proactive patrol and investigative techniques, alert citizens, and a proactive approach towards quality of life and drug related offenses have contributed to increased arrest levels. Of these arrests, Officers filed a total of 250 felony charges, 501 misdemeanor charges, and 1,844 violation or petty offense complaints. Figure 2 represents an overview of adult arrests affected by members of the Port Jervis Police Department from 2001 through 2011.

Offense/Case reports are filed to document the occurrence of a crime or offense, or incidents that involve further investigation. In 2011, 2,114 Offense/Case Reports were filed representing a slight increase from 2010. Of these cases, a total of 424 felony offenses, 942 misdemeanor offenses, and 1,328 violation and other offenses were investigated. Note: some case reports represent multiple level charges or offenses. Table 1 represents a breakdown of the percentage of select offenses committed in each City Ward:

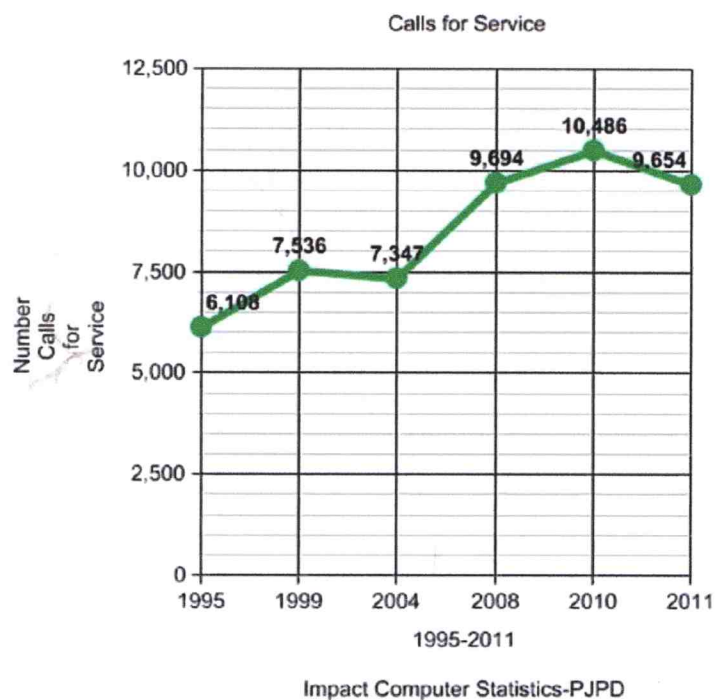

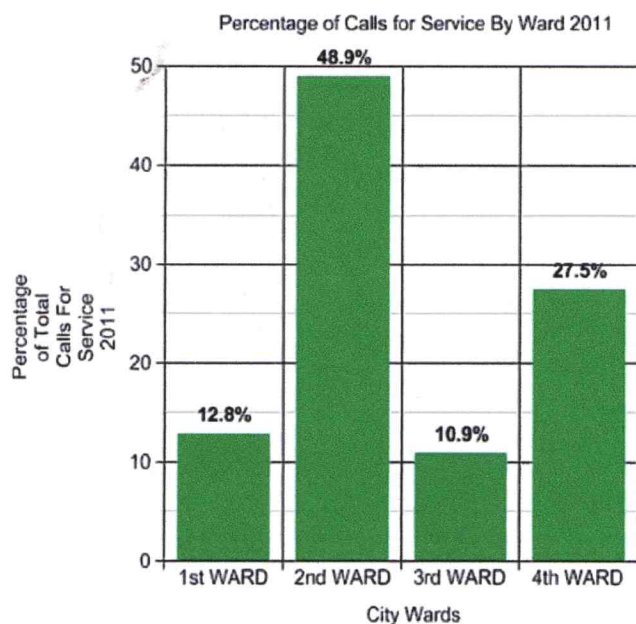
In 2011, officers investigated 9,654 incidents and calls for police services. This figure represents a 7.9% decrease from 2010. Statistically, the highest call volumes are experienced between the hours of 2pm to 10pm, with 8pm-10pm being the busiest hours during a twenty-four hour time period. Service calls may range from investigating 911 hang-ups, disturbances, rendering medical aid, performing assigned details and community policing initiatives, investigating motor vehicle accidents and domestic disturbances, to investigating violent and property crimes in progress, unattended deaths, and violations of the city code.

Calls for service have increased by 58% since 1995. Various factors may be attributed to an increase in service demands including community policing initiatives, proactive policing and intervention strategies, and the increase in service related functions provided by law enforcement.

Figure 3 represents total incidents investigated between the years of 1995 through 2011. :



The volume of calls generated for service and case reports filed vary by ward. Departmental computer statistics reveal that the bulk of police activity continues to occur in the City's Second and Fourth Ward. Both wards present a unique mix of residential neighborhoods, city parks, major city thoroughfares, and commercial businesses which can be attributed to higher levels of calls generated for service and offense reports filed. **Figure 4 represents total calls for service by City Ward:**



Traffic Safety

During 2011, the department participated in several state, local, and national traffic safety initiatives in an effort to reduce the occurrences of accidents that occur on our city streets in an effort to increase both pedestrian and motorist safety. The following is a summary of traffic safety programs and initiatives:

- New York State Governors Traffic Safety Bureau STEP Program "Selective Traffic Enforcement Program" and the Buckle up New York Program. These effective programs provide resources for the enforcement of seat belt laws, distracted and aggressive driving and accident causing behaviors.
- Interstate "Border to Border" Driving While Intoxicated Enforcement Periods with the Eastern Pike Regional Police Department.
- Participation in the Orange County Stop DWI Program.
- Representation on the Orange County Traffic Safety Committee.
- Creation of a new School Crossing Guard Post at the Port Jervis Middle School to improve traffic flow and pedestrian safety.
- Handicapped accessible crosswalk installed on East Main Street between North and South St.
- Increased traffic enforcement by patrol officers targeting accident causing driving behaviors.
- Deployment of Speed Display Trailer.
- Assignment of a sergeant to maintain speed enforcement equipment and conduct traffic and speed analysis of City streets.
- Focused speed enforcement details.
- Emergency Vehicle Operation and Driving While Intoxicated Training
- Operation Safe Stop Bus Safety and Student Crossing Campaign

Traffic Safety Related Statistics:

- 22% reduction in personal injury auto accidents.
- 30% reduction in driving while intoxicated arrests.
- 9.3% increase of operators operating a motor vehicle with a suspended driver's license.
- 21% increase in citations issued for motorists who fail to yield to pedestrians in a crosswalk.
- 8.6% increase in property damaged auto accidents.

Proactive enforcement efforts and public education are vital to promoting traffic safety. Since 2002, the City has experienced a 5.5% decrease in property damage related accidents, a 55.3% decrease in accidents involving personal injury, and a 50% reduction in accidents involving injuries to pedestrians since 2000.

Traffic safety initiatives will remain a priority in 2012 as the department plans to engage in the following initiatives:

- DWI/Distracted Driving Educational Lectures for Port Jervis High School Health Students.
- Partnering with the Dept. of Public Works to Enhance Crosswalk Signage
- Participation in the Empire State Law Enforcement Traffic Safety Conference
- Creation of a Traffic Safety Enforcement Award for Patrol Officers

Figure 5 represents motor vehicle accidents involving personal injury and property damage by occurrence in each city ward. 48% of all traffic related accidents occur in the Second Ward while 28% occur in the Fourth Ward. The 2nd and 4th Ward are geographically located in areas that contain the City's main thoroughfares resulting in a higher density of vehicular and pedestrian traffic. East Main Street, West Main Street, Kingston Avenue, Pike Street, Fowler Street, Front Street, and Jersey Avenue account for the vast majority of all traffic related collisions investigated by police. Computer statistics reveal that traffic accidents are prone to occur between the hours of 10a.m. -6p.m. generally caused by distracted or aggressive driving behaviors.

Figure 5. Motor Vehicle Accidents by City Ward

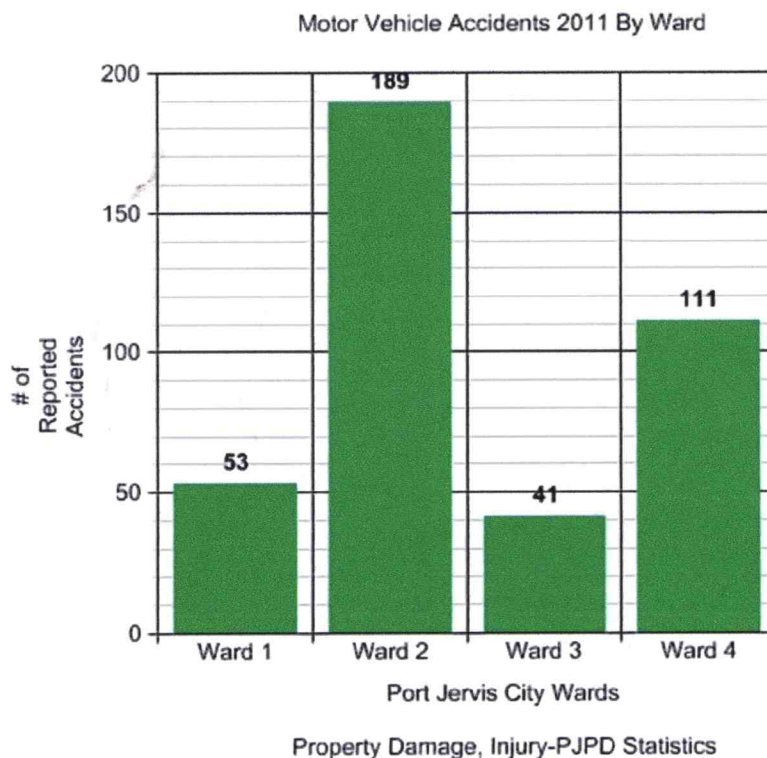
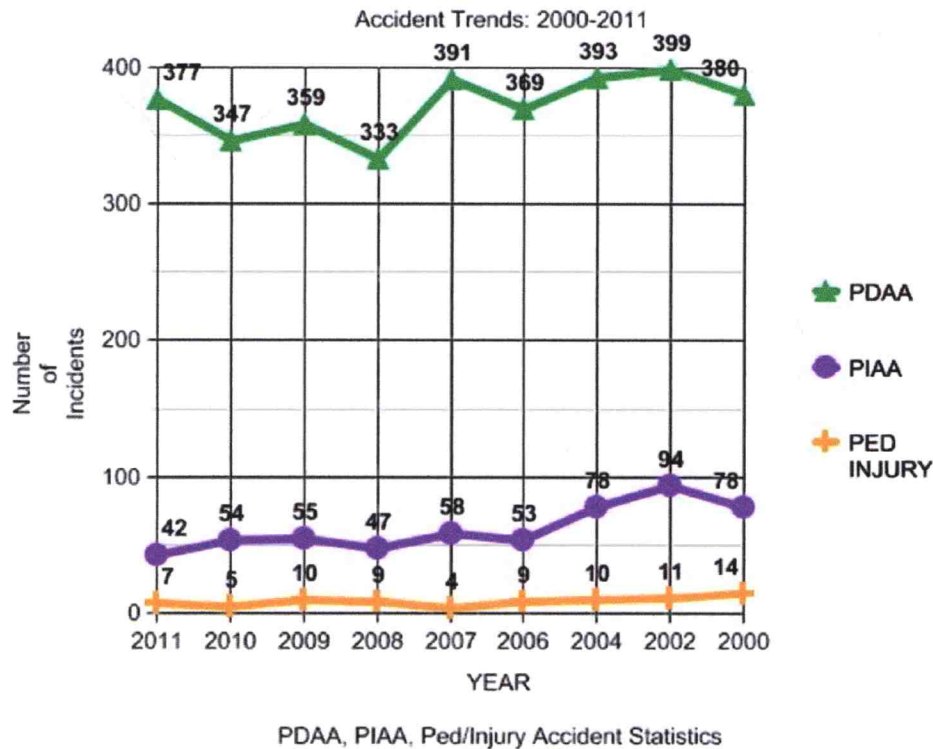


Figure 6. Accident Trends: 2011-2000 (Present to Past Order)



Community Policing and Crime Prevention

Providing crime prevention and community outreach is an essential component of our overall crime reduction strategy. The Department's Crime Prevention Officer and rank and file police officers work closely with community organizations and our thriving neighborhood watch groups to provide valuable crime prevention information and awareness. In addition, the department maintains a public crime map, crimereports.com that provides timely public information with regards to police activity occurring throughout the City of Port Jervis to increase citizen knowledge and participation with crime control.

Community service is woven in the fabric of the officers who serve our city. Many of our police officers are heavily involved in community organizations and volunteer their off-duty time in youth activities, scholastic and youth sporting programs, local civic groups, churches, and other community based institutions.

As evidenced in the attached Juvenile Aid Bureau and School Resource Officer yearly reports, proactive youth crime prevention efforts are the focal point of the department's approach to addressing juvenile crime and disorder. The department continues to work closely with the Port Jervis Recreation Department, Orange County Youth Bureau, the Port Jervis City School District

and various community organizations to provide positive, interactive services to our area residents and youth in an effort to suppress criminal behavior and provide positive intervention services.

Juvenile Aid Bureau: Juvenile Activities and Crime Statistics

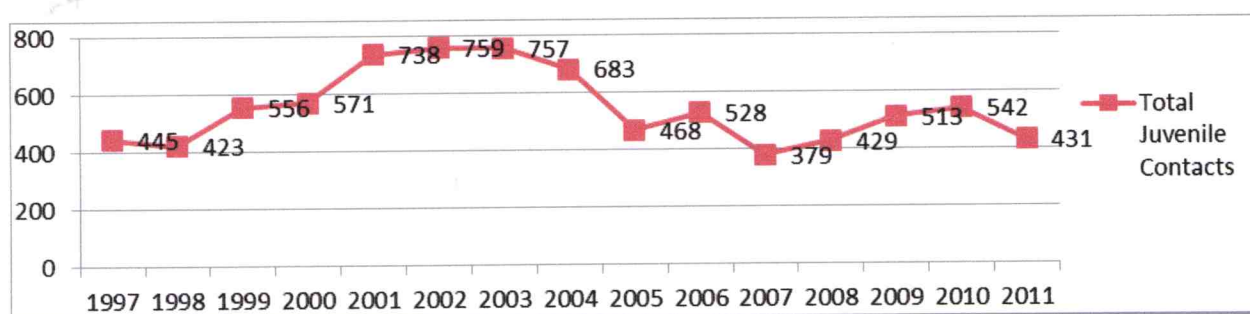
School Resource Officer /Drug Abuse Resistance Education

Juvenile related crime and disorder continues to present a challenge for policing our community. The purpose of the Juvenile Aid Bureau is to provide positive crime prevention initiatives coupled with proactive intervention and criminal investigation strategies to address issues of juvenile crime and disorder. A Juvenile Detective is responsible for the day to day activities conducted within the Juvenile Aid Bureau and is assisted, as needed, by the School Resource Officer and uniformed police officers.

The Juvenile Aid Bureau works in partnership with an array of community service organizations, non-profit institutions, county agencies, the Port Jervis City School District, and the Port Jervis Recreation Department, on a daily basis to provide proactive intervention services to prevent and address juvenile criminality and at-risk behaviors.

Between 1997 through 2001, overall Juvenile Contacts with police authorities have declined. Specifically, contacts with juveniles peaked in 2003 at 759 and have since declined by over 43%. Figure 7 represents total Juvenile Contacts with police from 1997-2011.

Positive declines can be partially attributed to the numerous proactive youth crime prevention and intervention strategies deployed by our Juvenile Aid Bureau, School Resource Officer Program, and Drug Abuse Resistance Education Program.

In 2011, our Drug Abuse Resistance Education/School Resource Officer Kelly Decker successfully educated and graduated his final DARE class consisting of approximately two hundred 5th grade students. In addition, he performed a DARE component to 8th grade Middle School students and completed his tenure as a public servant in June, 2011. Officer Scott Robertson was subsequently appointed to replace Officer Decker and has fulfilled these roles with great enthusiasm and pride.

In 2012, Det. Buczek will be working closely with the HONOR.EHG Youth Services Committee to ensure that adequate shelters are available for teenagers in need. In addition, the Juvenile Aid Bureau will be introducing the *Total Transformation Program: A Parents Program for Managing Challenging Child Behavior*. This new, innovative model will be provided on a trial basis to individual families who are experiencing disobedient and disorderly youths. The program provides a step by step plan for stopping defiance, back-talk, lying and disrespect, and will be offered to participating families and youth services agencies as a valuable educational learning resource offering real world practical solutions for the most challenging problems that parents face, acting out in school, cursing, lying, defiance, disrespect, unmotivated behavior, and more. The techniques offered in this multi-media presentation will help children take responsibility for their behavior and empower parents to take back control of their homes.

2011 Major Accomplishments

1. Stabilization of crime and disorder through proactive patrol operations, community policing, and investigative resources targeting major crime and narcotics offenses, crime prevention, and building strong partnerships with our neighborhood watch groups and citizens.
2. Enhanced crime prevention initiatives and community outreach performed by the Juvenile Aid Bureau, Dare Program, School Resource Officer, Canine Unit and Crime Prevention Unit.
3. 5th Annual National Night Out Against Crime Celebration on August 2, 2011. This successful community policing event attracted over 2000 persons and over thirty organizations ranging from non-profit organizations serving our community, health systems, social services, education, government, law enforcement, churches, and business organizations.
4. Development of a professional departmental in-Service training program utilizing departmental trainers, outside training resources and on-line training to provide effective training programs for our officers.
5. Participation with the Orange County Department of Emergency Services Automated Vehicle Locator (AVL) Program.

Each year, thousands of telephone calls are received at the Orange County 9-1-1 Center and the Port Jervis Police Central Dispatch from individuals reporting incidents where the lives and safety of the public are threatened. It is critical to those callers, as well as to the victims of such emergencies, that all steps are taken to ensure the timely response of sworn law enforcement officers.

Orange County initiated the AVL project of to ensure that such immediate response is achieved through the use of automatic vehicle locators installed in marked primary police patrol vehicles of 31 law enforcement agencies throughout Orange County including the City of Port Jervis. Utilizing this technology, Port Jervis Police communications personnel have access to pinpoint geographical information, computerized mapping, and dispatching software that automatically identifies the closest police unit to all emergency priority calls reported and to identify the last known location of police units in the field.

Port Jervis City Police have the ability to monitor and communicate with adjacent law enforcement resources such as the Town of Deerpark Police, the Orange County Sheriff's Department, and the New York State Police, to coordinate immediate emergency resources to assist our officers and community during major incidents.

2012 Goals, Initiatives, and Challenges

1. Continue to provide professional, community oriented policing services to our community, working collaboratively with our residents and neighborhood watch groups to solve problems, build relationships, and combat quality of life concerns, property and violent crimes, and narcotics offenses, to improve the quality of life in our community.
2. Increase departmental transparency and the public dissemination of information by enhancing the Department's website and the creation of social media outlets.
3. Revise and update the Department's Mission Statement, Core Values, and Slogan to reflect our commitment to provide professional community oriented policing services to our community.
4. Continue participation in the New York State Department of Criminal Justice Services Accreditation Program to maintain and enhance the level of professional policing services we provide. The benefits of Accreditation include controlled liability insurance costs, increased defense against litigation and civilian complaints, improved employee morale, professional excellence through the development of accredited policy and procedures, and increased public understanding and support of police operations and management.
5. Provide effective community crime prevention and youth intervention programs to foster positive police/community relationships and improved transparency. To accomplish this goal, the department will participate in the 6th annual National Night Out Against Crime, provide crime prevention seminars addressing Fraud and Senior Citizen Safety, Women's Self Defense, and Prescription Drug Abuse and Our Community.
6. Explore funding opportunities to provide part-time civilian dispatching for the police department's central communications desk. Civilian dispatchers would provide relief to supervisory officers currently assigned communication duties allowing them to focus their supervisory duties and talent to enhance supervision, patrol operations, investigations, community policing activities, and engage in problem solving activities.
7. Deploy effective traffic safety and education strategies to improve motorist and pedestrian safety in an effort to reduce traffic accidents in our community and enhance pedestrian safety.
8. Continue to develop and enhance professional in-service training programs and career development for our sworn officers and civilian employees.
9. Improve Animal Control Services provided to the community through increased collaboration with our local veterinary and humane society professionals, development of effective Animal Control Policy and Training Programs, and the hiring an additional Animal Control Officer.

- ◆ **January 2011** Ptl. Kelly Decker begins teaching the DARE program to 257 fifth graders in two elementary schools three days per week for ten weeks.
- ◆ **March 2011** I prepared 50 Child ID cards for the children at Project Discovery.
- ◆ **March 2011** I prepared 24 Child ID cards for the children at Snips & Snails preschool.
- ◆ **April 2011** The Juvenile Aid Bureau established a "Tip-line" so Port Jervis youth could call or text the Juvenile officer with questions or concerns.
- ◆ **June 2011** I prepared 77 Child ID cards for children attending the Matamoras Police Dept sponsored Community Day @ Airport Park.
- ◆ **June 2011** S.R.O. Decker & I gave an internet safety lecture to attending parents & students at the Port Jervis Middle School.
- ◆ **June 2011** I attended the "Career Day" at the A.S.K. school and spoke with students about the profession of Law Enforcement. In addition, I gave out 11 bicycle helmets and 24 bike locks to needy students.

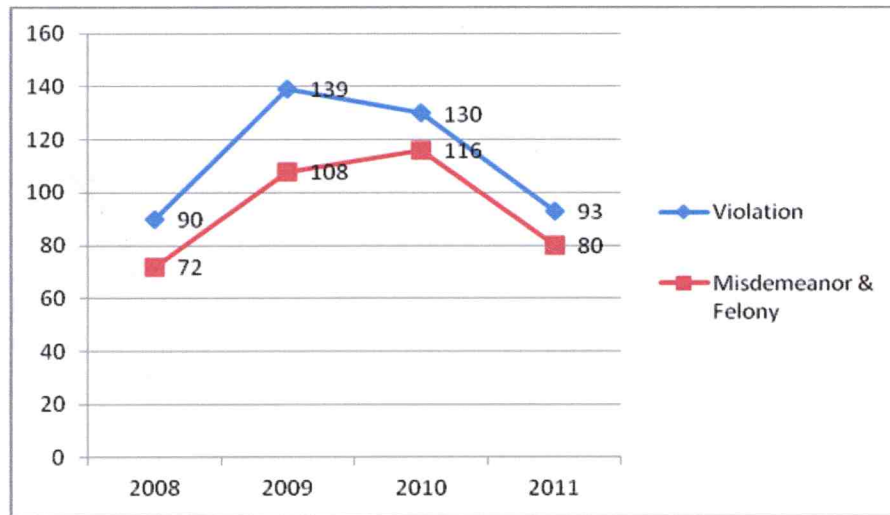

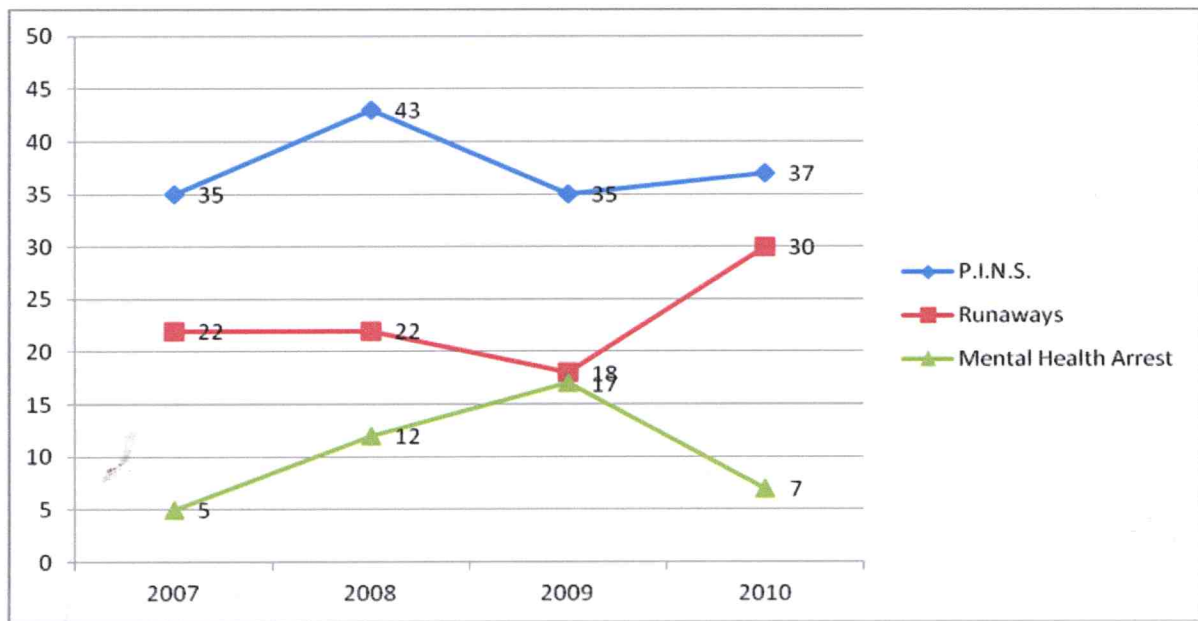

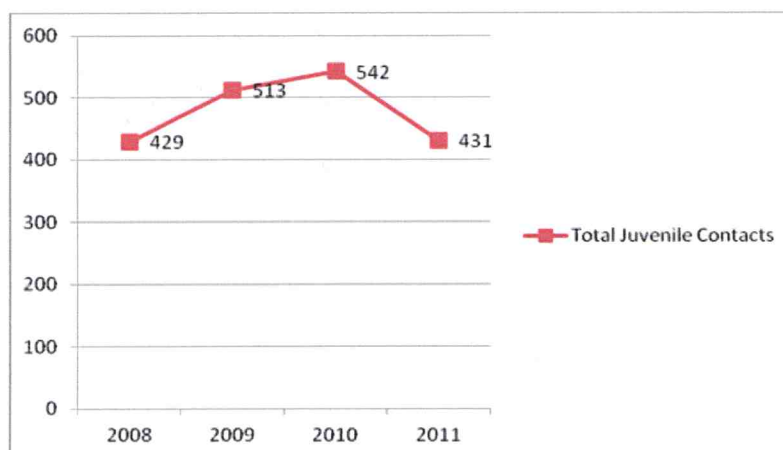

Felony level charges increased nearly 60% over 2011, reflecting the Detective Divisions aggressive enforcement of narcotics laws. 18 individuals were charged with sale and/or possession with intent to sell a controlled substance. Heroin and crack cocaine remains among the top of the predominant dangerous drugs of abuse, with marihuana also representing a large percentage of drug abuse. The increase in prescription narcotic abuse and sales has increased steadily and in 2011 presented as a major drug of abuse, and the largest in terms of seizure. The trend towards increased abuse of prescription narcotics is consistent with national drug abuse trends which indicate that this form of drug abuse is the fastest growing in the country.

NARCOTICS AND DANGEROUS DRUG DESTRUCTION

During the late summer and early fall of 2011, Detectives conducted an inventory of dangerous drugs, narcotics and controlled substances that were no longer required as evidence. On September 30, 2011, Detectives obtained a Port Jervis City Court order authorizing the destruction of the inventoried drugs and On September October 11, 2011, Detectives transported the drugs to a facility designated for the properly disposal and destruction of drugs.



DEATH INVESTIGATIONS

Death investigations increased 10% from 2010, and nearly 18% when compared with 2009 death investigations. Death investigations are broken down by manner of death as follows:

Selected investigations and arrests

On February 2, 2011, Todd Sinclair, age 26, of Florida, New York, shot and killed lifelong Port Jervis resident Randy Kizer, age 21, on Prospect Street. Sinclair fled the scene and was later apprehended in the Town of Monroe. Port Jervis Police Detectives charged Sinclair with Murder in the 2nd degree, Manslaughter in the 1st degree, Criminal use of a firearm in the 1st degree, Criminal possession of a weapon in the 2nd degree, and Reckless endangerment in the 1st degree, all felonies. The case is currently awaiting trial in Orange County Court.

During 2011 seven persons died of accidental overdoses in the City of Port Jervis, highlighting the ongoing problem with drug abuse, including prescription narcotics. The current trend is that overdoses are not related to one particular drug taken in a lethal dose, but in the combined effects of multiple drugs taken together in less than lethal doses. In many cases prescription narcotics and/or anti-anxiety medications are used in conjunction with alcohol and/or illicit drugs (e.g. heroin, cocaine). This 'poly drug intoxication' can prove lethal despite the individual doses being within acceptable or less than lethal doses. It is also important to note that therapeutic doses and recreational illicit use doses are often very different, and habitual users will develop a tolerance for a particular drug, necessitating an increase in the dose required to obtain a desired effect.



SEARCH WARRANTS

Detectives obtained and executed 18 search warrants during 2011, 16 of which were issued out of Port Jervis City Court, and 2 out of Orange County Court.

LONG TERM INVESTIGATIONS

The detective division maintains several open, long term investigations that were either initiated prior to 2011, or commenced during the year 2011. These cases typically require extensive investigative time and effort, as well as investigative support in the form of court subpoenas and witness interviews. DNA evidence, including

FOOD STAMP ABUSE INVESTIGATION

In December 2010 a member of the neighborhood watch provided confidential information that an employee of A&H Deli on Culvert Street was allowing persons to purchase cigarettes, alcohol and lottery tickets using New York State Public Benefits Cards intended only for use in purchasing foods (Food Stamp Program). Working with investigators with the New York State Office of Temporary Disability and Assistance, detectives obtained a public benefit card under a fictitious identity assigned to a Port Jervis City Police Officer. That officer was then able to make transactions on numerous days using the benefits card to purchase alcohol, tobacco and



lottery tickets. On March 5, 2012, detectives concluded the investigation by executing a Port Jervis City Court search warrant at the deli and arresting VishalkumSakariya, a 26 year old alien resident of New Jersey. He was charged with numerous offenses and later pled guilty in Port Jervis City Court.

TRAINING

In addition to training provided in-house, detectives participated in several excellent training opportunities in 2011:

- Death investigation techniques sponsored conducted by the New York City Office of the Medical Examiner and sponsored by the Orange County Medical Examiner's Office.
- Forensic Anthropology conducted by the New York City Office of the Medical Examiner and sponsored by the Orange County Medical Examiner's Office.
- Infant death investigations conducted by the New York City Office of the Medical Examiner and sponsored by the Orange County Medical Examiner's Office.
- Meth abuse and clandestine lab awareness.
- HTIDA Gang graffiti presentation.
- Investigation and intelligence gathering for terrorist threats and investigations conducted by a retired member of MI-5, the British intelligence agency.

COMMUNITY PRESENTATIONS

Detectives participated in community presentations including:

- 4th Ward Neighborhood Watch – Prescription Narcotics Abuse
- City wide – seminar on citizen involvement in crime prevention

MAJOR CRIMES

In previous years selected cases were summarized by month. For this report, only selected cases will be highlighted under specific categories of criminal offenses.

SEX OFFENSES

Eight individuals were arrested for sex offenses in 2011. A total of six felony level offenses and six misdemeanor level offenses were charged.

DNA EVIDENCE



DNA evidence recovered at crime scenes have yielded two hits with offenders who were required to submit a DNA sample as a result of a criminal conviction. In both cases, the offense was committed prior to 2011 and both are pending further investigation. Arrests are anticipated.

CRIMES AGAINST PERSONS:

ROBBERY

Four individuals were arrested and charged with robbery, and several cases remain open and are pending arrests for robbery.

Selected investigations and arrests

On June 1, 2011, at 9:26 AM, on East Broome Street, a 77 year old female was robbed by Ryan Rhodes, of Laxawaxen, PA, and Brookline, Massachusetts, after she had left Citizens Bank. The victim was not injured during the robbery and Rhodes fled the scene. Detectives were able to obtain a search warrant for the victim's phone, which had been taken in the robbery, and obtained GPS coordinates for the phone. Rhodes was subsequently located by Brookline, Mass., Police, and arrested. He was later extradited to New York for court proceedings on charges of Robbery in the 1st degree and Robbery in the 2nd degree.

ASSAULT

37 charges were filed for misdemeanor assault, and 12 for felony assaults.

Selected investigations and arrests

A 17 year old male was arrested at 1:20 AM on May 28, 2011 and charged with Assault in the 1st degree after stabbing another subject while in a vacant house. The defendant has pled guilty in Orange County Court and is awaiting sentencing.

On October 6, 2011, a Port Jervis Police Detective Sergeant attempted to stop one David Lombardo of Marlboro, New York, for a traffic infraction. Lombardo failed to comply and led police on a high speed pursuit through the lower fourth ward section of the city. In the course of fleeing, Lombardo twice rammed a Port Jervis Police vehicle. After coming to a stop on South Street, Lombardo resisted arrest and struggled with officers, attempting to stab one of them with a screwdriver. Lombardo was taken into custody and charged multiple felony offenses, including Assault, criminal mischief and reckless endangerment. Lombardo has been indicted by an Orange County Grand Jury, and the case is waiting further court action.

STANGULATION AND RELATED OFFENSES

Under this relatively new section of the penal law 9 different persons were arrested and charged with either misdemeanor Criminal obstruction of breathing or circulation, or felony level Strangulation in the 1st or 2nd degree.



CRIMES AGAINST PROPERTY:

BURGLARY

31 persons were arrested and charged with either Burglary in the 1st, 2nd or 3rd degree, felonies. The Detective Division has active, ongoing investigations into several open burglary cases from 2011.

CONCLUSION

2011 presented new challenges with the increase in narcotic prescription abuse and overdose deaths. This is a trend that will continue in 2012 and is a serious threat to the community. Continued enforcement of narcotics laws as applied to prescription sales and abuse will continue. The increase in crack cocaine, as well as the steady abuse of heroin, are also drug abuse priorities that will continue to be the focus of aggressive enforcement.

Information from Port Jervis Neighborhood Watch groups continues to be a vital link in the chain of information. The long term nature of narcotics investigations often relies upon license plates, vehicle and suspect descriptions, and times and locations provided by watch members. The division looks forward to continuing that relationship. Increased participation in presentations to watch groups and other civic organizations are planned for 2012.
